### Parent/Guardian:

- I will assist my child in ensuring that they arrive to school on time and stay on campus for the full instructional day.
- I will contact the school if my child/children are not able to attend school due to illness or other reason(s) and ensure that they complete any missed assignments within the required time frame. Students are allowed one day per absence to complete makeup assignments.
- I will engage with my child/children's teachers regularly regarding their academic, behavioral and social-emotional progress.
- I will ensure that there is an area in my home that has limited distractions (noise, people, etc.) for my child to complete homework and other assignments while off-campus.
- I will participate in parent involvement activities provided by the school including the monthly Parent and Family Engagement Meetings and at least one parent/guardian conference per quarter.
- I understand that my child/children must abide by the cell phone expectations outlined in the Panther P.R.I.D.E. Student Handbook. Failure to do so will result in my child/children's cell phones being confiscated and checked into the office for the school day.

#### Students

- I will be prepared and ready for learning daily and stay on campus for the full instructional day.
- I will adhere to the Panther P.R.I.D.E. Universal Guidelines while in class, on campus, and on school-coordinated field trips.
- I will ask my instructor(s) for support if I do not know how to access my class materials and resources.
- If I am absent from class, I will complete any missed assignments within the required time frame. I understand that I am allowed one day per absence to complete make-up assignments.
- I will dress in EPA-approved attire while on campus.
- I will dress in EPA-approved attire while on field trips as requested by the administration.
- I will ensure that I am in an appropriate learning space with limited distractions (noise, people, etc.) while completing homework or projects at home.
- I will not engage in distracting behaviors that will negatively impact my teacher's ability to teach or the learning of myself/others
  during instruction. This includes:
  - Adhering to the expectation that my cell phone/headphones are checked in with the teacher during each class period.
  - Refraining from bringing unauthorized snacks into the classroom and eating them during instructional time.

## <u>School</u>

- Math Goals: Everglades Preparatory Academy <u>math learning gains</u> will increase by at least 3% from 35% to 38%.
- ELA Goals: Everglades Preparatory Academy ELA learning gains will increase by at least 3% from 47% to 50%.
- EPA instructors will provide optional "office hours" and appropriate interventions to support students in need of additional supports.
- EPA instructors will engage parents regularly through progress reports, parent conferences and other parental involvement opportunities via TeacherEase, mailings and call-outs.
- EPA instructors will work collaboratively with administration, community partners, parents/families, and students to ensure that the <u>Social</u>, <u>E</u>motional, and <u>L</u>earning (SEL) needs of each student are met.
